### **SEWER RATES**

NOTE: Sewer charges are based on water usage. The minimum Residential rate is 21.44 FOR zero usage, then \$3.10 per 1,000 gallons of water usage.

The minimum for Commercial Customers is 25.65 then \$3.73 per 1,000 gallons.

Sewer Charges are based on a three month average once each year. The months are; January, February, and March and adjusted with July billing for August 1.

Customers with no history are charged the minimum plus 5 thousand gallons until a history is established.
