5. Citizens Presentations

There were no citizens presentations.

6. Approval Of Minutes Of Previous Meeting(s)

Alderman Mike Malone offered the motion to approve the minutes of the previous meeting. Alderwoman Claudia Cabriales seconded the motion. Voting in favor of the motion were, Alderwoman Valencia Price, Alderwoman Pamela Teel, Alderman Malone, and Alderwoman Cabriales. Motion carried.

7. Update on Police Department Activity

Chief Gary Fountain gave the update on the police department's activity for the month of August. Activity included: cases filed 41; 0 felony arrests; 12 misdemeanor arrests; 2 assist other agencies; 84 responses on calls for service; 0 juvenile case; 2 auto accident response/report; 88 citations; and 88 warnings. Chief Fountain also reported that the department made an arrest on a warrant obtained on Barrett Street and recovered several items that had been stolen from the Magnolia Park area along with several drugs.

8. Judge Betty Loggins – Update On Municipal Court Activity

Judge Betty Loggins reported 72 citations and collections of \$3,285.20 for the month of August.

9. <u>Tracy Cox – Update On Main Street Program</u>

Main Street Manager Tracy Cox gave an update on the Main Street Program. Activity for the month of August included committee meetings of the Advisory Boards; Commissioners Court meeting; American Main Street Patriots Day planning meeting; Workforce Solutions meeting in Center, TX; visited with business owner about National Main Street Pilot program; and submitted a proposal to Texas Main Street Program for a grant handled by National Main Street Projects San Augustine Main Street. Upcoming events include: Movie in the Park October 29, 2016; Christmas Jubilee Days will be held December 1-2, 2016; and Junk in the Trunk Trades Day is December 3, 2016.

10. Update From City Manager Randy Whiteman

City Manager Randy Whiteman gave an update of city activity to the council. Activities included:

11. Discussion And Action If Any To Approve Maintenance Agreement With TxDOT

14. <u>Discussion And Action If Any To Consider Awarding The Bid For The TCF Grant</u>

Alderman Malone offered the motion to reject the bid for the Texas Capital Fund Grant Main Street Improvement from the lone bidder Drewery Construction. Alderwoman Cabriales seconded the motion. Voting in favor of the motion were Alderwoman Price, Alderwoman Teel, Alderman Malone, and Alderwoman Cabriales. Motion carried.

15. <u>Discussion and Action If Any To Authorize The Re-advertising For Bids For The Texas</u> Capital Fund Main Street Sidewalk Grant
