6. Approval Of Minutes Of Previous Meeting(s)

Alderman Mike Malone offered the motion to approve the minutes of the previous meeting. Alderwoman Valencia Price seconded the motion. Voting in favor of the motion were, Alderwoman Price, Alderwoman Panela Teel, Alderman Malone, and Alderman Dan Fussell. Motion carried.

7. <u>Update on Police Department Activity</u>

Chief Gary Fountain gave an update on the police department's activity for the month of October. Activity included: cases filed 17; 3 felony arrests; 1 misdemeanor arrests; 7 assist other agencies; 83 responses on calls for service; 0 juvenile case; 2 auto accident response/report; 75 citations; and 62 warnings.

8. Judge Betty Loggins – Update On Municipal Court Activity

Judge Betty Loggins was absent. Mayor Hughes reported 69 citations and collections of \$3,510.00 for the month of October.

9. Tracy Cox – Update On Main Street Program

Main Street Manager Tracy Cox gave an update on the Main Street Program. Activity for the month of October included committee meetings of the Advisory Boards; City Council and Chamber membership meetings; attended Texas Downtown Association training at Waxachie, TX; received a grant in the amount of \$1200.00 to pay for oral history kiosk and partner with Stephen F. Austin State University; will be trying to implement "Pop-ups" business in San Augustine; December 4 and 5 is Christmas Jubilee; Junk-in-Trunk is December 12; and she is currently redoing the Christmas decorations for the downtown area.

10. <u>Update From City Manager Randy Whiteman</u>

City Manager Randy Whiteman gave an update of city activity to the council. Activities included:

- (1) The crew is working on getting ready for Christmas, putting lights on buildings
- (2) Working on repairing leak at Sr. Citizen's Building and replacing the broken window.
- (3) Met with Texas Historical Commission last week and was informed that the commission will take the City's offer to a three person committee for evaluation and report back to the commission in January in San Antonio, TX.
- (4) Working with Dr. Neway on solar power plant
- (5) City auditors will present audit at December meeting.

11. <u>Discussion and Action If Any To Award A Grant Management Firm To Provide</u> Administrative Services For 2015 TxCDBG Project

The City only received one proposal for the above item, Raymond K. Vann & Associates. Alderman Malone offered the motion to approve Raymond K. Vann & Associates for administrative services for the 2015 TxCDBG project. Alderwoman Teel seconded the motion. Voting in favor of the motion were, Alderwoman Price, Alderwoman Teel, Alderman Malone, and Alderman Fussell. Motion carried.

12. <u>Discussion and Action If Any To Award An Engineering Firm To Provide Services For</u> 2015 TxCDBG Project

Two proposals were received for the above item, Everett Griffith, Jr. and Associates, Inc. and KSA. City Manager Whiteman scored the proposals and based upon the scores he recommended that the council award the services to KSA. Alderman Malone offered the motion to approve KSA for engineering services for the 2015 TxCDBG project. Alderman Fussell seconded the motion. Voting in favor of the motion were, Alderwoman Price, Alderwoman Teel, Alderman Malone, and Alderman Fussell. Motion carried.
