5. <u>Discussion and Action If Any Authorizing 2015 Purchase Agreement Between The</u> <u>City of San Augustine and San Augustine Rural Water Supply Corporation</u>

City Manager Randy Whiteman explained to the council that San Augustine Rural Water Supply and Bland Lake Water Supply are combining because they are having to do dual reporting to Texas Commission on Equality and it is costing them more money because it is two entities. The council was given a new agreement between the City and the Rural Water Supply for consideration. Alderwoman Valencia Price offered the motion to accept the agreement between The City of San Augustine and San Augustine Rural Water Supply Corporation. Alderman Dan Fussell seconded the motion. Voting in favor of the motion were Alderwoman Price, Alderwoman Pamela Teel, Alderwoman Claudia Cabriales, and Alderman Fussell. Motion carried.

6. <u>Discussion and Action If Any Authorizing Mayor Leroy Hughes To Sign</u> <u>Memorandum Of Understanding Between Integrated Power Systems, Inc. and City of</u> <u>San Augustine.</u>

Mayor Hughes had been given a Memorandum of Understanding between Integrated Power Systems, Inc. and The City of San Augustine to construct and operate a 20MW solar photovoltaic facility to sell the generated solar electric energy directly to the City of San Augustine under a twenty-five(25) year Power Purchase Agreement. Representatives from Integrated Power Systems, Inc. were Dr. Neway Argaw, Joseph Lavigne, and Jeff Pointer to discuss the memorandum with the council. After discussion, Alderwoman Teel offered the motion to allow Mayor Hughes to sign the memorandum of understanding between Integrated Power Systems, Inc. and The City of San Augustine that is non-binding and is the revised memorandum that was provided by Attorney Wade Flasowski. Alderwoman Teel, Alderwoman Cabriales, and Alderman Fussell. Motion carried.

7. Discussion – Options For Long Range Planning For The City of San Augustine

Alderman Fussell expressed his concern for the City of San Augustine to have long range plans for our City, workshops and citizen participation. He shared some of the things he learned at the Texas Municipal League's conference in September. The council will set a date for planning at future meeting.
