6. Approval Of Minutes Of Previous Meeting(s)

Alderman Mike Malone offered the motion to approve the minutes of the previous meeting. Alderwoman Valencia Price seconded the motion. Voting in favor of the motion were, Alderwoman Price, Alderwoman Pamela Teel, Alderman Malone, Alderwoman Claudia Cabriales, and Alderman Dan Fussell. Motion carried.

7. Update on Police Department Activity

Officer Cameron Nichols gave an update on the police department's activity for the month of August. Activity included: cases filed 38; 1 felony arrests; 8 misdemeanor arrests; 12 assist other agencies; 87 responses on calls for service; 0 juvenile case; 4 auto accident response/report; 42 citations; and 64 warnings.

8. <u>Judge Betty Loggins – Update On Municipal Court Activity</u>

Judge Betty Loggins reported 34 citations and collections of \$2741.20 for the month of August.

9. Tracy Cox – Update On Main Street Program

Main Street Manager Tracy Cox gave an update on the Main Street Program. Activity for the month of August included committee meetings of the Advisory Boards; City Council and Chamber membership meetings; attended training in San Marcos; submitted grant application to Anice Read Fund for oral kiosk; had successful Junk in the Trunk; and guest speaker at Logansport Chamber of Commerce. Linda Goller read a letter received from Senator John Coryn in reference to the first responders event held in San Augustine. On November 4th will be a Christmas Craft show, November 5th is Texas Downtown Association Roundtable Discussion, and November 7th is Junk in the Trunk.

10. <u>Update From City Manager Randy Whiteman</u>

City Manager Randy Whiteman gave an update of city activity to the council. Activities included:

- (1) The City of Diboll will host a Texas Municipal League Small Cities Clinic on October 30, 2015
