5. Canvass The November 4, 2014 Election

Mayor Hughes read result of the November 4, 2014 election. Alderman Joe Verhalen offered the motion to approve the totals as presented. Alderwoman Pamela Teel seconded the motion. Voting in favor of the motion were Alderwoman Valencia Price, Alderwoman Teel, and Alderman Verhalen. Motion carried.

8. Approval of Minutes of Previous Meeting(s)

Alderman Verhalen offered the motion to approve the minutes of the previous meeting. Alderwoman Price seconded the motion. Voting in favor of the motion were Alderwoman Price, Alderwoman Teel, and Alderman Verhalen. Motion carried.

9. Update on Police Department Activity

Chief of Police Gary Fountain gave the update on the Police Department for the month of October. Activity included: cases filed 39; 8 misdemeanor arrests; 3 assist other agencies; 128 responses on calls for service; 4 auto accident response/report; 84 citations; and 48 warnings.

10. <u>Judge Betty Loggins – Update On Municipal Court Activity</u>

Judge Loggins reported 67 citations and collections of \$4046.10 for the month of October. She also performed two weddings.

11. <u>Tracy Cox – Update On Main Street Program</u>

Main Street Manager Tracy Cox gave an update on the Main Street Program. Activity for the month of October included committee meetings of the Advisory Board and promotion committee meetings; Filed ten criteria report before October 6 deadline; held movie/dinner theater fundraiser; partnered with Chamber of Commerce for Kids Alley for Sassafras Festival; junk in the trunk; trick or trunk; and received notice that San Augustine Main Street is among the four cities eligible for funding by the 2014 Texas Capital Funding Main Street Program grant of \$150,000.00

12. <u>Discussion and Action If Any To Grant Permission To Tressie Simon To Apply For Texas Parks and Wildlife Grant To Help Create An Outdoor Youth Program</u>

Mrs. Tressie Simon had asked permission to apply for a grant from the Texas Parks and Wildlife Department. The program will help the youth to acquire knowledge and skills through the Department of Texas Parks and Wildlife. The grant is directed toward inner-city, rural, low-income, minority, female, physically and mentally challenged, and youth-at-risk. The grant requires a zero match from the City. Alderman Verhalen offered the motion to grant permission to Tressie Simon to apply for Texas Parks and Wildlife Grant. Alderwoman Price seconded the motion. Voting in favor of the motion were Alderwoman Price, Alderwoman Teel, and Alderman Verhalen. Motion carried.

13. Discussion and Action if Any To Amend City of San Augustine 2014 Holiday Schedule

City Manager Bruce Milstead asked the council to amend the City of San Augustine 2014 holiday schedule to change the days off for Christmas from Wednesday and Thursday, December 24 and 25 to Thursday and Friday, December 25 and 26.
