## 8. <u>Discussion And Action To Approve Proposed Agreement Between The City of San</u> <u>Augustine and Deep East Texas Communications To Lease Two Water Towers For</u> <u>Telecommunications Equipment</u>

Jeremy Burcham with Deep East Texas Communications (Tenant) presented an agreement to the council for approval to use a portion of the building and tower on Hwy. 96 and Milam Street for the purposes of placing, operating and maintaining on the site, telecommunications equipment to provide internet service to the City of San Augustine and surrounding areas. The tenant shall provide, during the term of this agreement, a 10mb download / 5mb upload Internet Connection to San Augustine

City Hall, hosting of web site and email at cosatx.com, and off-site backup of server data at no fee. Alderman Malone offered the motion to accept the proposal with the addition to Article 1 Section N to add provide services to the Police Department and Travel Center. Alderman Verhalen seconded the motion. Voting in favor of the motion were Alderwoman Teel, Alderman Malone, Alderman Verhalen, and Alderwoman Simon. Motion carried.

### 9. Update On Police Department Activity

Chief Gary Fountain gave an update on the police department's activity for the month of December. Activity included: cases filed 30; 5 felony arrests; 5 misdemeanor arrests; 7 assist other agencies; 93 responses on calls for service; 5 auto accident response/report; 63 citations; and 34 warnings. The Council was also given a Racial Profile Report for year 2013.

### 10. Judge Betty Loggins – Update On Municipal Court Activity

Mayor Hughes reported 55 citations and collections of \$2908.10 for the month of December.

### 11. Tracy Cox – Update On Main Street Program

Main Street Manager Tracy Cox gave an update on the Main Street Program. Activity for the month of December included; attended meetings of city council, advisory board meeting and organization committee chair and promotion committee chair meeting; met with City Council in special meeting to give Austin resource team visit report; attended ribbon cutting within the city; met with videographer about the editing of DVD – San Augustine Founding Document; judging the Deep East Texas Electric Cooperative Christmas decorating door contest; Texas Friendly Customer Service training; and attended the Daughter of the Republic of Texas Home Tour event.
