6. Approval of Minutes of Previous Meeting(s)

Alderman Marcus Hafford offered the motion to approve the minutes of the previous meeting(s). Alderwoman Pam Teel seconded the motion. Voting in favor of the motion were, Alderman Dan Fussell, Alderman Herman Wilson, Alderwoman Pam Teel, Alderman Juan Diaz and Marcus Hafford. Motion carried.

7. Update on Police Department Activity

In the absence of Chief Shannon Brazeal, Mayor Hughes gave the update on the police department's activity for the month of February. Activity included: reports filed 34; 7 felony arrests; 9 misdemeanor arrests; 2 assist other agencies; 231 responses on calls for service; 0 juvenile case; 4 auto accident response/report; 32 citations; 122 warnings; and 0 completed mental health warrants.

8. <u>Judge Jeff Cox – Update on Municipal Court Activity</u>

It was reported that 34 citations were received and collections of \$1274.00 for the month of February. Remitted to State - \$738.00 and City retention - \$536.00

9. Liz Jones - Update on Main Street Program

Main street has prepared a "Downtown Spring Promotion" which is basically a loyalty program. There will be a list of participating businesses and when you visit them, you get a "punch" on your card. When you have visited 10 businesses, you will return your cards to Main Street and are eligible for prize drawings. This will be held from March 27 thru April 10, 2022.

Also, she reminded us of "Sale on The Trail" which will be held the first week of May. San Augustine will be having participants set up on the square to take advantage of those traveling the trail looking for bargains.

The San Augustine "Pop up Shops" will be starting again on March 31 and April 1.

10. Update from City Manager Jeaneyse Mosby

- The property across from City Hall was bought at the County Auction. The city was the only bidder and secured the property for \$6000 which was the opening bid.
- 3 vehicles were purchased to add to the city fleet. 1 for the Street Department, and 2 for the Water Department. Although one of these was purchased for the Meter Reader, the height of the truck was difficult for him to use. Vehicles will be interchanged in the fleet to accommodate each department more efficiently. None of these were NEW vehicles, but new to us, including one that was already outfitted with a lift eliminating the need to rent this type of equipment for any future projects.

11. <u>Discussion and Action to approve a Licensing Agreement made by and between the City of San Augustine, a general law municipal corporation of the State of Texas and Spectrum Gulf Coast, LLC, a limited liability company organized under the laws of the State of Delaware, and subsidiary of Charter Communications, Inc., with its principal place of business in Stamford, CT.</u>

This is a licensing agreement that would be between the City and Spectrum Gulf Coast, LLC which is a subsidiary of Charter Communication. This is the internet company with the hub located on North Clark Street. They are planning to come in on HWY 96 from Jasper coming down FM 2213 following our service lines ending at their hub. It is a 5-year agreement with an auto renewal. The city will invoice them annually by September 1. The reimbursement is for a one-time Admin Fee of \$25 and then a \$15.00 per pole attachment fee, along with post construction inspection fee that will be at actual cost if necessary. The minimum number of poles for the city will be 10. City Attorney Wade Flasowski reviewed the agreement and noted that it looks acceptable to him with the notation of making sure the above mentioned pricing and invoicing requirements are acceptable and need to be followed. The 5-year renewal date needs to be indicated as well to make sure that it remains current and include any necessary adjustments be made.

Alderman Dan Fussell offered the motion to approve the licensing agreement that will be between the City and Spectrum Gulf Coast, LLC which is a subsidiary of Charter Communication with a 5-year agreement with an auto renewal as stated as long as it is followed. Alderman Marcus Hafford seconded the motion. Voting in favor of the motion were, Alderman Dan Fussell, Alderman Herman Wilson, Alderwoman Pam Teel, Alderman Juan Diaz and Marcus Hafford. Motion carried.
