6. Approval of Minutes of Previous Meeting(s)

7. Update on Police Department Activity

Chief Shannon Brazeal gave the update on the police department's activity for the month of April. Activity included: reports filed 32; 4 felony arrests; 7 misdemeanor arrests; 1 assist other agencies; 253 responses on calls for service; 0 juvenile cases; 1 auto accident response/report; 36 citations; 96 warnings; and 1 completed mental health warrants.

8. Judge Jeff Cox – Update on Municipal Court Activity

Judge Cox reported that 33 citations were received and collections of \$633.00 for the month of April. Remitted to State - \$232.00 and City retention - \$401.00 He was able to attend the Seminar for Judges which focused on Traffic Safety.

9. Liz Jones - Update on Main Street Program

The city has submitted its application to be considered to host the Smithsonian Institute and the Texas Historical Society to host a "Museum on Main Street". We should know by June 15 if we were chosen to host.

The San Augustine Annual Heritage Days Festival will be held June 2 and 3. The vendors will set up on Friday and the full Festival will open on Saturday. Johnson Saw Shop will be honored with the Texas Treasure Business Award.

10. Update from City Manager Jeaneyse Mosby

- We did have a few water leaks that were repaired with little or no interruption of service to the citizens.
- The water superintendent is working on the yearly CCR that must be completed by the end of June.
- Budget season will be beginning soon. If the Council has anything they want to see added to the budget, please let the City Manager know prior to the first budget workshop if at all possible.
- Contractors will be in the city evaluating the areas of FM 2213 and MLK. They will be preparing a bid to complete some need upgrades in those areas.
- Mike Perry has expressed the desire to install a charging station for Electrical Vehicles the City will partner with them for the necessary upgrades and installations.

11. Discussion and Action to Award Bids of Retired Fleet Vehicle

The vehicle is the S10 Truck that had previously been used by the meter reader. After some inquiries of a desire to purchase it were made from the public, the decision was made to open it up for bids. Only one bid was made. This bid was from Ken and Amanda Jones in the amount of \$200.
