5. Citizens Presentations

Stephen Hays spoke to the council about the hiring of the new city manager. He informed the council that he as the press was not notified of the called meetings to interview the applicants. He feels that the press should always be notified of all meetings.

6. Approval Of Minutes Of Previous Meeting(s)

7. <u>Update on Police Department Activity</u>

Chief Gary Fountain was absent. Mayor Hughes gave the update on the police department's activity for the month of July. Activity included: cases filed 33; 4 felony arrests; 11 misdemeanor arrests; 1 assist other agencies; 56 responses on calls for service; 1 juvenile case; 6 auto accident response/report; 105 citations; and 105 warnings.

8. Judge Betty Loggins – Update On Municipal Court Activity

Judge Betty Loggins was absent. Mayor Hughes reported 90 citations and collections of \$5,983.04 for the month of July.

9. <u>Tracy Cox – Update On Main Street Program</u>

Main Street Manager Tracy Cox gave an update on the Main Street Program. Activity for the month of July included committee meetings of the Advisory Boards; City Council meeting; Commissioners Court meeting; An American Main Street 9-11 event to be held on September 11 from 5 p.m. to 8 p.m.; will have conference call with American Main Street to discuss upcoming facade grants; Junk in the Trunk Trade Day – Saturday September 2, 2017; and Christmas Parade December 1, 2017.

10. Update From Interim City Manager Leroy Hughes

Interim-City Manager Leroy Hughes gave an update of city activity to the council. Activity included:

- 1. The council held interviews on Friday August 11, 2017 for the city manager position and chose John Camp for the position. His starting date of employment is September 5, 2017. There will be a called meeting scheduled to confirm the employment.
- 2. Laskey Bell, water/wastewater employee was life flighted to Houston Herman Hospital last Sunday. Electrical Lineman Charles Evan's wife is ill.
- 3. Water/Wastewater Superintendent Chris Anding reported that doors have been installed on the new water plant building. The building is nearly complete with the only thing left to do is install exhaust fans. Select fill for the above ground storage tanks is being hauled in and prepared for installation of the tanks.

11. <u>Discussion and Action If Any To Approve 2017 Property Tax Rate And To Schedule Two Public Hearings If Necessary</u>

Alderwoman Cabriales offered the motion to approve the effective tax rate of \$0.641454 per \$100.00 property value for 2017 property tax rate. Alderwoman Price seconded the motion.
