6. Approval Of Minutes Of Previous Meeting(s)

7. Update on Police Department Activity

Chief Gary Fountain gave the update on the police department's activity for the month of March. Activity included: cases filed 79; 3 felony arrests; 11 misdemeanor arrests; 3 assist other agencies; 72 responses on calls for service; 0 juvenile case; 3 auto accident response/report; 150 citations; and 104 warnings.

He explained that at last month's meeting Mr. Sonny Hubbard asked the council to approve a 5% rate increase in residential garbage rates to be effective August 1, 2017. Mr. Hubbard was not informed by his company that the contract between the City and Piney Woods Sanitation allowed for a CPI increase without the council's approval. The information given by Mr. Hubbard should have been for information only as per the contract.
