#### Vaccine Allocation Resources for Texas Public Health Entities

## Vaccine Allocation and Ordering System (VAOS)

VAOS is the DSHS system of record for COVID-19 vaccine ordering and allocation. It provides provider-level access to doses allocated, doses accepted, doses rejected, inventory on hand, and doses received. VAOS receives data daily from ImmTrac2 regarding the number of vaccinations completed by each vaccinator and reported to ImmTrac2. The ImmTrac2 data is used to calculated available inventory, doses administered, and similar data points. Copies of reports can be exported at the facility level.

#### COVID-19 Vaccine Data Dashboard

The COVID-19 Vaccine Data Dashboard (Tableau dashboard) allows local health entities (LHEs) to monitor their jurisdiction's vaccine distribution, supply, and administration metrics. It provides jurisdictional-level access to doses allocated, doses accepted, doses rejected, inventory on hand, and doses received for all COVID-19 vaccine providers within each LHE's jurisdiction.

**Please note:** Local health entities (LHEs) who are also COVID-19 vaccine providers will have access to two Dashboards, one for viewing their jurisdictional vaccine metrics and one for viewing their individual provider vaccine metrics. If your organization also serves as a COVID-19 Vaccine Provider, please reference the <u>COVID-19 VAOS - Provider User Training Guide</u> for instructions on how to use the Vaccine Allocation and Ordering System (VAOS) to access your Provider Dashboard.

#### **Critical Population Estimates**

The Texas Population Data for COVID-19 Vaccine Planning Application is a resource that Texas local health entities (LHEs) and local health authorities (LHAs) can use to identify critical population estimates at the county level.

To access county-level estimates of critical populations, please take the following actions:

- 2. In the search bar, type the name of your county
- Once your county name appears in the results, click on the row to view the county record

The table below outlines the types of critical population estimates available within the application. Please note that individuals may fall into multiple categories.

Frontline Workers	<ul> <li>Healthcare personnel (e.g., EMS, hospital staff, vaccinators, pharmacy and long-term care staff)</li> <li>Other frontline workers (e.g., first responders, education, others with critical roles who cannot easily social distance)</li> </ul>
People at increased risk for severe COVID-19 illness	<ul> <li>People 65 years of age and older</li> <li>Long-term care facility (LTCF) residents (e.g., nursing home, assisted living centers, others)</li> <li>People with underlying medical conditions that are risk factors for severe COVID-19 illness</li> </ul>
People at increased risk of acquiring or transmitting COVID-19	<ul> <li>People from racial and ethnic minority groups</li> <li>People from tribal communities</li> <li>People who are incarcerated/detained in correctional facilities</li> <li>People attending colleges/universities</li> <li>People living in other congregate living settings other than correctional facilities or LTCFs</li> </ul>
People with limited access to routine vaccination services	<ul> <li>People living in rural communities</li> <li>People with disabilities</li> <li>People who are under- or un-insured</li> </ul>

#### **Texas Critical Population Facility Directories**

The Texas Population Data for COVID-19 Vaccine Planning Application also outlines all facilities within each county that may be eligible for COVID-19 vaccination (based on the phased approach to COVID-19 vaccine allocation). If the facility is currently enrolled as a DSHS COVID-19 vaccine provider or enrolled with CDC to be matched with a pharmacy through the CDC Pharmacy Match Program, the facility record indicates those enrollments.

- 2. County Jails (273 facilities)
- 3. Day Activity and Health Services (DAHS) Providers (~440 facilities)
- 4. Emergency Medical Services (EMS) Providers (~750 facilities)
- 5. Federal Bureau of Prison Facilities (19 facilities)
- 6. Home and Community Support Service Agencies (HCSSA) (~7,300 facilities)
- 7. Hospitals (~644 facilities)
- 8. Immigration and Customs Enforcement (ICE) Detention Facilities (30 facilities)
- 9. Intermediate Care Facilities (ICF-IIDs) for Individuals with an Intellectual Disability or Related Condition (~950 facilities)
- 10. Nursing Facility (~1,244 facilities)
- 11. Prescribed Pediatric Extended Care Center (5 facilities)
- 12. State Supported Living Centers (13 facilities)
- 13. Texas Department of Criminal Justice Facilities (state prisons) (107 facilities)
- 14. Texas State Veterans Homes (9 facilities)

#### ImmTrac2 Vaccine Administration Reports for Public Health Entities

Following the execution of a data sharing agreement with the DSHS Immunization Unit, public health entities can access reports of COVID-19 doses administered to individuals in their jurisdictions by all vaccinators. The purpose of these reports is to assist local health entities in assessing vaccination coverage and to provide data that can be used for reminder/recall efforts related to any subsequent doses needed.

## Vaccine Adverse Event Reporting System (VAERS)

This is the adverse event reporting system for all vaccines, not only COVID-19 vaccines. VAERS is co-managed by FDA and CDC to serve as an early warning system for detection of possible safety issues with U.S. vaccines occurring after vaccination. All healthcare providers are required to report adverse events that occur after COVID-19 vaccines even if they are not sure the vaccine caused the event.
